# **Call for Art**

Florida Gateway College and the Gateway Art Gallery are hosting an exhibition of art by current FGC students Spring 2018 term. The exhibition will be held at the Gateway Art Gallery located at 168 N. Marion Avenue in downtown Lake City, Florida. An opening reception will take place on Friday, February 2, 2018 from 5:30 pm-7 pm. The exhibition will remain on view during Gallery hours through Thursday, March 29th, 2018.

### Eligibility

This exhibition is open to currently enrolled Florida Gateway students. Along with entry materials, a copy of the student's valid FGC ID is required.

There is no entry fee to participate. All works must be for sale. The Gateway Gallery will retain a 30% commission on all works sold during the exhibition. Students may enter a maximum of two original works of art. Prints, reproductions and craft kits

FLORIDA GATEWAY COLLEGE are not eligible.

Both two-dimensional and three-dimensional works in any medium are eligible. Two-dimensional work must not exceed 24" w x 30" h, must be framed with Plexiglas and wired to hang. No glass or saw tooth hangers allowed. Three-dimensional work must not exceed 25lbs. and 12" w x 12"h x 24" d. Secure packaging of threedimensional work is required for transport (i.e. box with packing material).



#### Delivery and Pick-up of Work

The College will provide transportation of artwork to and from FGC to the Gateway Art Gallery, excluding work sold during the exhibition.

Work must be hand delivered to The Hall on the FGC campus on Wednesday, January 10, 2018 or Thursday, January 11, 2018 between the hours of 3:00 pm-4:30 pm. Entries not delivered during these times will not be accepted. A completed Entry Form, FGC Student Travel, FGC Media Release, and Gateway Art Gallery Artist Release and Waiver of Liability are required. A copy of a valid student ID must also be provided. Incomplete entries will not be accepted.

Three-dimensional works must be securely packaged for transport. The FGC faculty and staff are not responsible for damage in transport of artwork.

Work not sold during the exhibition will be available for pick-up at The Hall on Tuesday, April 3, 2018 or Wednesday, April 4, 2018 between the hours of 3:00 pm-4:30 pm.

The Gateway Art Gallery will handle sales of student work during the exhibition. The Gallery will retain a 30% commission on sale and will work directly with the artists for payment. FGC faculty and staff are not involved in the purchasing process.

- 2. The artist is responsible for the delivery, pack, transport, provide for the return of their artwork and hanging of the artwork at their own risk and expense.
- 3. The Artist understands that the artwork submitted to GAG and exhibited at the Artist's own risk and that GAG nor any of its officers, agents, and employees shall be responsible for theft, vandalism, fire or any other damages or losses to the artwork. The Artist understands and agrees that GAG makes no representations or warranties regarding the level of security in the facility. The Artist understands and agrees that GAG makes no representations or replacement of lost, agents, and employees will not be responsible for reimbursement or replacement of lost, stolen, or damaged artwork and GAG does not insure such submitted artwork.
- 4. The Artist understands and agrees that GAG encourages the owner of the artwork or the owner's agent to obtain an insurance policy for the artwork or to obtain a rider on any existing policy for the duration of the exhibit.
- 5. The Artist shall indemnify, save and hold harmless GAG, its officers, directors, employees, volunteers and agents from any and all claims, demands, causes of action and judgements, losses, costs and expenses, including but not limited to reasonable attorney's fees, arising due to the negligence of the Artist, their employees, agents or personnel hereunder, including but not limited to any representation, warranty, term, and/or condition of this Agreement.
- 6. The Artist agrees to be paid seventy (70%) percent of the sale price of their artwork, and agrees that GAG receive thirty (30%) of the sale price of their artwork, commonly referred to as a 70/30 split.
