

NOTICE OF INTENT TO AWARD

FLORIDA GATEWAY COLLEGE ITB# 20-2-01 ROADWAY RESURFACING PROJECT – PHASE 1

INTENT TO RECOMMEND AWARD: In accordance with Florida Gateway College Board of Trustees Policy 6Hx12:5-01, the President intends to award Roadway Resurfacing Project – Phase 1 to C.A. Boone Construction, Inc. of Columbia County in the amount of \$117,380.00.

Any person who is adversely affected by the College’s decision or intended decision shall file with the College a notice of protest in writing within 72 hours after the posting of the notice of decision or intended decision.
The formal written protest shall be filed within 10 days after the date the notice of protest is filed. Failure to file a notice of protest or failure to file a formal written protest and required bond shall constitute a waiver of proceedings under this chapter. The formal written protest shall state with particularity the facts and law upon which the protest is based. Saturdays, Sundays, and state holidays shall be excluded in the computation of the 72 hour time periods provided by this paragraph.

Failure to file a protest within the time prescribed in Section 120.57(3), or failure to post the bond or other required security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, Florida Statutes.
