- **3.** Construction tasks for this project consist of, but are not limited to, construction of a 700 +/- LF driver safety & training track, of varying width, as part of phase 2 of the Olustee Public Safety Training Complex and completion of an "As Built" survey. Construction project based on specification in the engineer's project (No. L180401FGC)
- **4.** Any additional site visits are by appointment only.
- **5.** Only prequalified contractors can bid this project. To be considered for qualification, Contractors must request, complete, and submit a prequalification package not later than **5:00 p.m. (EST) on September 14, 2022**.

- **8.** Contractors should check the College's Procurement & Contracts solicitation webpage at https://www.fgc.edu/florida-gateway-college/procurement-contracts/solicitations-goods-services/ for award or recommended award notices and all addendums.
- **9.** Bid proposals will be received electronically via FGC Dropbox with instructions provided in the Bid Documents.
- **10.** All bid proposals must arrive prior to the 5:00 P.M. September 30, 2022 bid closing. Late bid proposals will not be accepted. The College will not be responsible for delays that cause a Bid Proposal to arrive after the designated bid opening date/time.
- **11.** Bid proposals will be opened via Zoom meeting in a public bid opening in electronic format and can be viewed by Bidders.
- **12.** A Performance Bond in the sum of not less than 100 percent of the contract amount will be required for any resulting contract in excess of \$100,000.00. The bond shall be delivered to the Owner with the executed contract.
- 13. Once the contract has been awarded, it will need to be executed within seven (7) calendar days from the date of receipt and returned to the College along with all required bonds and insurance certificates.
- **14.** Work may begin upon receipt of the Notice to Proceed. Work shall be finally complete two calendar months after Notice to Proceed has been issued.
- **15.** Liquidated damages are \$250.00 per calendar day until final completion is reached.
- 16. Contractor shall provide Owner with a one (1) year warranty from the date of final completion.
- **17.** Any submitted questions submitted that cannot be responded to by the public response date will still be stated and provided with a response that says the response is pending the engineer reply.

18. Open Discussion

Contractor Questions:

- i. Are Bidders required to carry a Bid Bond and/or a Performance Bond?
 - Answer: (Mike Lee) A bid bond is not required, in the Pre-Qualification Packet bidders must show their capacity to carry a Performance Bond up to 100% of any work performed in excess of \$100,000.
- ii. The College is wanting the pond to be filled in by approximately six inches?
 - Answer: (Mike Lee) Yes, in accordance with the engineering plans call for the pond floor to be raised by approximately six inches to meet the requirements established to ensure the pond floor is the required number of feet above the water table.
- iii. Is the contractor required to obtain permitting for this project through Baker County?

Answer: (Mike Lee) Yes, you would be required to apply for and receive all receive any applicable permits for this project.

iv. Is the contractor required to obtain a building permit?

Answer: (Mike Lee) We do not need a building permit as there is nothing being constructed which would call for a construction permit.

v. Are the new cedar trees required to be relocated or can they be removed?

Answer: (Mike Lee) The contractor will be required to dig them up and the College will relocate and replant the trees.

vi. Asphalt is very unstable right now, is there going to be anything in the contract on the ITB which would address issues with obtaining sufficient asphalt to complete the project or if asphalt prices skyrocket in the near future?

Answer: (Aaron Mathews) The upcoming Addendum to the current ITB will address a very small portion of the asked questions. You would review the Addendum and bid accordingly.
